

Privacy Statement

Personal data processed by us:

Special and/or sensitive personal data

Retention period

Home of Recruitment does not keep your personal data longer than strictly necessary to achieve the goals for which your data are collected. Data will only be kept of persons with regard to whom a similar job is likely to occur in the future. Permission will always be requested first. The retention period applied by us is 3 years. After this period, your data will be permanently deleted.

Sharing personal data with third parties

Home of Recruitment does not sell your data to third parties and provides them only if necessary for the implementation of our agreement with you or to meet a statutory obligation. We make a processing agreement with companies that process your data on our behalf, to ensure the same level of security and confidentiality of your data. Home of Recruitment will still be responsible for this processing.
